STORAGE AND DISPOSAL:

Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight. Triple containers before disposal. Add rinsings to spray tank. 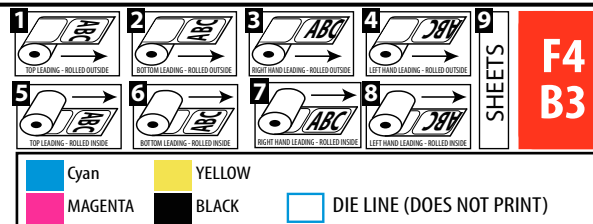
