PROTECTION OF CROPS, NATIVE AND OTHER NON-TARGET PLANTS

Susceptible crops include but are not limited to clovers, cotton, fruit, hops, lupins, ornamentals, peas, pine trees, potatoes, navy beans, safflower, shade trees, soybeans, sunflower, tobacco, tomatoes, vegetables and vines. SUREFIRE STAROX 400 HERBICIDE can be damaging to susceptible crops during growing and dormant periods. Grasses are normally unaffected by SUREFIRE STAROX 400 HERBICIDE and establish quickly after treatment. Transitory damage can occur on some species, particularly those that spread by stolons such as couch grass (Cynodon dactylon), Kikuyu grass and carpet grass (Axonopus sp.)

DO NOT allow spray to drift onto susceptible crops, shade trees and Pinus spp.  
DO NOT use under weather conditions or from spraying equipment which could be expected to cause spray to drift onto nearby susceptible plants.

PROTECTION OF LIVESTOCK

DO NOT graze or cut treated crops for stock food except as specified under withholding periods.  
Poisonous plants may become more palatable after spraying.  
DO NOT allow stock to re-enter paddocks containing treated poisonous plants until the plants have died down.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or waterways with the chemical or used containers. Alongside waterways, treat only noxious weeds and poisonous plants.

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight.  
Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

Refillable containers

Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

Do not tamper with the Micro Matic valve or the security seal. DO NOT contaminate the Envirodrum with water or any foreign matter. After each use of the product, please ensure that the Micro Matic coupler, delivery system and

hoses are disconnected, triple rinsed with clean water and drained accordingly. When the contents of the Envirodrum have been used, please return the empty Envirodrum to the point of purchase. The Envirodrum remains the property of PCT Holdings Pty Ltd.

SMALL SPILL MANAGEMENT

Wear protective equipment (see SAFETY DIRECTIONS). Apply absorbent material such as earth, sand, clay granules or cat litter to the spill. Sweep up material for disposal when absorption is completed and contain in a refuse vessel for disposal (see STORAGE AND DISPOSAL section). If necessary, wash the spill area with an alkali detergent and water and absorb as above the wash liquid for disposal.

SAFETY DIRECTIONS

Avoid contact with eyes and skin. When opening the container, preparing the spray and using the prepared spray, wear cotton overalls buttoned to the neck and wrist and a washable hat, elbow-length PVC gloves, face shield or goggles. Wash hands after use. After each day's use wash gloves, face shield or goggles and contaminated clothing.


