### **Environmental Persistence & Degradation:**

Bromadiolone is not expected to volatilize from dry soil surfaces (SRC) as it has a very low vapour pressure. Bromadiolone is not persistent in soil under aerobic conditions (half-life 14 days), and can generally be considered immobile except in soils of low organic matter and clay, such as sand.
